## MODIFICATION TWO TO COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM AGREEMENT BETWEEN THE COUNTY OF DUPAGE AND CAROL STREAM PARK DISTRICT PROJECT NUMBER CD22-04

THIS MODIFICATION TWO TO AGREEMENT is entered into this day of June, 2024 by and between the COUNTY OF DU PAGE, Illinois (hereinafter called "COUNTY") and Carol Stream Park District, with a principal place of business located at 849 W Lies Road, Carol Stream, Illinois 60188, (hereinafter called "SUBGRANTEE"). The purpose of this MODIFICATION TWO TO AGREEMENT is to modify an existing agreement between the above parties known as Community Development Commission Agreement CD22-04, which was originally adopted by Resolution #HHS-R-0052-22 on February 8, 2022, followed by County Board approval of a \$400,000 funding increase, adopted under Resolution #HHS-R-0327-22 on August 23, 2022, to grant funding in the amount of \$1,000,000.00 of which \$50,000.00 is unexpended, for the purpose of rehabilitation of the existing recreational facilities and construction of new recreational facilities within Community Park located at approximately 745 Thornhill Drive, Carol Stream, IL 60188. Modification One to the Agreement was entered into on December 13, 2023, which was approved by the Director of Community Services, for the purpose of a time extension to extend the period covered by the Agreement to 07/01/2024, (hereinafter, together with any previous modifications thereto, called "Agreement").

In consideration of the premises of the Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree to the following modification of the terms of the Agreement in accordance with Section XII. A. of the Agreement:

- 1. The time period covered by the Agreement is hereby extended to September 1, 2024.
- 2. Section XI. A. Progress Schedule 2. Is hereby modified extending the date to September 1, 2024.
- 3. Section XI. B. is hereby modified to extend the completion of the project to September 1, 2024.

In all other respects, the terms and conditions of the Agreement shall remain in full force and effect.
