**RELEASE**

On roll call, Executive Session began at 11:29 AM. Members Cahill, Chaplin, Childress, Covert, DeSart, Eckhoff, Evans, Galassi, Garcia, Gustin, LaPlante, Ozog, Rutledge, Schwarze, Tornatore, Yoo, and Zay voted “aye”. Members Covert and Krajewski were absent.

Assistant State’s Attorney Lisa Smith was present in the boardroom.


