Approve contract increase of \$90,000.00 to supply polymer at both Woodridge and Knollwood Wastewater Treatment Plants for sludge de-watering and thickening.

Polymer is utilized in both the Woodridge and Knollwood Wastewater Treatment Plants for sludge de-watering and thickening. Due to timing of contracts expiring, DuPage County Public Works anticipated two shipments of Polymer under the previous contract. Purchase Order number 5916SERV was closed at about \$137,000 in savings. The total amount of the increase is already budgeted in FY2024.

Polymer is crucial to the de-watering and thickening process at both wastewater treatment plants. This assists in all the costs associated with cake solids, capture rate, polymer dosage, and polymer cost, which decreases the overall wear on mechanical equipment at both wastewater treatment plants.

Sourcing was completed via a formal bid process under bid number 23-063-PW. Polydyne was the low-bid winner on and awarded the contract on 9/12/23.

- 1. Approve the contract increase of \$90,000.00. Recommended due to the need to maintain operations of sludge de-watering and thickening at both Woodridge and Knollwood Wastewater Treatment Plants.
