Request for approval of Change Order #7 to PURVIS Systems Incorporated PO 924025/7298-1 to add Quotes PC2026-100 and PC2026-148 for additional optional equipment for Winfield Fire and Itasca Fire and to document the revised milestone schedule for payment and accounting of contractual obligations. These equipment costs will be reimbursed by the agency to ETSB. Total amount of \$4,885.00, for a new contract amount of \$702,805.00.

Winfield Fire Protection District completed new fire Station #31 and is making a request for additional equipment for the station. Itasca Fire Department is in process of building Station #67 and is also requesting an exchange/addition of equipment to their build. Both agencies have previously signed an MOU with ETSB financially obligating their individual agency to the portion of this change order as listed on their quote.
