Requests for Statements of Interest were sent to firms throughout the industry and responses were received from 28 firms qualified to perform this work. Based on the review of the Statements of Interest, 3 firms were shortlisted and requested to submit a Statement of Qualification. The DOT reviewed each submittal taking into consideration the firm's understanding of the project, strategies to ensure timely completion of the project, experience on similar projects, and experience of key personnel. Based on a comprehensive review of the submittals, the DOT determined that the project team assembled by Thomas Engineering Group, LLC is qualified and has the staff available to perform the work on behalf of the County.
