GPN 008-24: FY 2025-2029 Surface Transportation Program (STP) -Illinois Department of Transportation-Federal Highway Administration-\$4,413,920 (Division of Transportation). 10. PRESENTATION

10.A. Cass Avenue Corridor Feasibility Study

County Engineer, Bill Eidson, gave an overview of the results of the feasibility study of Cass Avenue, from 91st Street to Concord Lane, which contained two major possible alternatives. The first was to install traffic signals to one or more of the intersections. The second was to install roundabouts at South Frontage Road and at Northgate. The complicating factor with any improvements in this corridor is the I-55 interchange itself. Any potential alternatives would need to be capable of working with the existing IDOT-owned interchange and also accommodate any future interchange plans that IDOT may eventually develop. The other option is to keep things as they are. The next step is to bring the study's results to IDOT and see if there are any interchange upgrades to come in the near future.

11.A. Metra Updates

Two representatives from Metra, Mr. Demetrios Skoufis and Mr. Daniel Miodonski joined the meeting remotely to give DuPage County some updates. Mr. Skoufis reviewed the upward moving trend of ridership on the three major Metra lines through DuPage County.

Mr. Miodonski gave an update on the schedules and the new fares.

Member Zay suggested a visit to the Wayne portion of the Illinois Prairie Path to review possible signage and other concerns in regard to the public comments. He also asked about the upgrades at the County Farm Road crossing. County Engineer Bill Eidson explained that there was a median refuge added, which seems to be helping and mentioned the IDOT policy which does not recommend flashing beacons.
