 - a) Item 1 when multiplied out resulted in an adjusted Extended Price with a increase of (\$27.00) \$75.00 x 135 = \$10,125.00.
 - b) Item 2 when multiplied out resulted in an adjusted Extended Price with a increase of (\$6.00) \$52.00 x 20 = \$1,040.00.
 - c) Item 6 when multiplied out resulted in an adjusted Extended Price with a decrease of (\$10.00) \$67.00 x 100 = \$6,700.00.
 - d) Item 8 when multiplied out resulted in an adjusted Extended Price with a increase of (\$2.00) \$97.00 x 12 = \$1,164.00.
