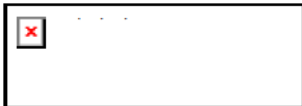

How can we consider having someone on the board making decisions about our money when she obviously doesn't handled her own properly.

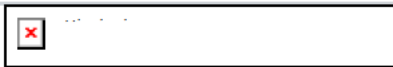
She has borrowed money and gave her word to pay it back.
