INDEPENDENT CONTRACTOR AGREEMENT

This AGREEMENT ("Agreement") is effective as of the 1st day of May 2026 and is entered into by and between the County of DuPage, a body politic and corporate ("County") and Storino, Ramello & Durkin, an Independent Contractor ("Individual").

RECITALS

WHEREAS the County desires that Individual render certain services more fully described herein; and

WHEREAS, the Individual has demonstrated expertise in providing such services, has represented that it has the requisite knowledge, skill, experience, and other resources necessary to perform such services and is desirous of providing such services for the County.

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants contained herein, the parties hereby agree as follows:

1. **Incorporation of Recitals:** The matters recited above are hereby incorporated into and made a part of this Agreement.
2. **Term:** This Agreement is for a term commencing, May 1, 2026, through April 30, 2027 ("Term"), unless terminated sooner as provided herein.
3. **Termination**
 - 3.1 Except as otherwise set forth in this AGREEMENT, County shall have the right to terminate this AGREEMENT for any cause or without cause thirty (30) days after having served written notice upon the Contractor, except in the event of Contractor's insolvency, bankruptcy or receivership, in which case termination shall be effective immediately upon receipt of notice.
 - 3.2 Upon such termination, the liabilities of the parties to this AGREEMENT shall cease, but they shall not be relieved of the duty to perform their obligations up to the date of termination, or to pay for deliverables tendered prior to termination. There shall be no termination expenses.
 - 3.3 Upon termination of this AGREEMENT, all data, work products, reports and documents produced, because of this AGREEMENT shall become the property of the COUNTY. Further, Consultant shall provide all deliverables within fourteen (14) days of termination in accordance with the other provisions of this AGREEMENT.
4. **Scope of Services:** Individual agrees to provide the services required and, if applicable, set forth on Exhibit "A" including the deliverables set forth thereon ("Services"), in accordance with the terms and conditions of this Agreement. The County may, from time to time, request changes in the scope of Services. Any such changes, including any increase or decrease in Individual's fees, shall be documented by an amendment to this Agreement in accordance with State and County laws.
5. **Compensation and Payment:** Compensation for Services during the initial term shall be based on an hourly rate of \$275.00/hour for partners, with a total that shall not exceed One Hundred Fifty Thousand Dollars, (\$150,000.00), with no reimbursement for expenses. Compensation shall be based on actual services performed during the Term of this Agreement and the County shall not be obligated to pay for any services not in compliance with this Agreement. In the event of early termination of this Agreement, the County shall only be obligated to pay the fees incurred up to the date of termination. In no event shall the County be liable for any costs incurred or services performed after the effective date of termination as provided herein. Consultant shall submit invoices referencing this Agreement with such supporting documentation as may be requested by the County. Payments shall be subject to 50 ILCS 505, "Local Government Prompt Payment Act". Payment will not be made on invoices submitted later than six-months (180 days) after delivery of goods and any statute of limitations to the contrary is hereby waived.

6. **Non-appropriation:** Expenditures not appropriated in the current fiscal year budget are deemed to be contingent liabilities only and are subject to appropriation in subsequent fiscal year budgets. In the event sufficient funds are not appropriated in a subsequent fiscal year by the County for performance under this Agreement, the County shall notify Individual, and this Agreement shall terminate on the last day of the fiscal period for which funds were appropriated. In no event shall the County be liable to the Individual for any amount in excess of the cost of the services rendered up to and including the last day of the fiscal period.
7. **Events of Default and Remedies.**
- 7.1 Events of Default. Events of default include, but are not limited to, any of the following:
(i) Any material misrepresentation by Individual in the inducement of this Agreement or the performance of Services; (ii) Breach of any agreement, representation or warranty made by Individual in this Agreement; or (iii) Failure of Individual to perform in accordance with or comply with the terms and conditions of this Agreement.
- 7.2 Remedies. In the event Individual defaults under this Agreement and such default is not cured within fifteen (15) calendar days after written notice is given by the County, the following actions may be taken by the County: (i) This Agreement may be terminated immediately; and (ii) The County may deem Individual non-responsible for future contract awards. The remedies stated herein are not intended to be exclusive and the County may pursue any and all other remedies available at law or equity.
8. **Standards of Performance:** Individual agrees to devote such time, attention, skill, and knowledge as is necessary to perform Services effectively and efficiently. Individual acknowledges and accepts a relationship of trust and confidence with the County and agrees to cooperate with the County in performing Services to further the best interests of the County.
9. **Assignment:** This Agreement shall be binding on the parties and their respective successors and assigns, provided however, that neither party may assign this Agreement or any obligations imposed hereunder without the prior written consent of the other party.
10. **Confidentiality and Ownership of Documents.**
- 10.1 Confidential Information. In the performance of Services, individual may have access to certain information that is not generally known to other ("Confidential information"). Individual agrees not to use or disclose to any third party, except in the performance of Services, any confidential information or any records, reports or documents prepared or generated as a result of this Agreement without the prior written consent of the County. Individual shall not issue publicity news releases or grant press interviews, except as may be required by law, during or after the performance of the Services, nor shall individual disseminate any information regarding Services without the prior written consent of the County. Individual agrees to cause its personnel, staff and/or subcontractors, if any, to undertake the same obligations of confidentiality agreed to by Individual under this Agreement. The terms of this Paragraph 10.1 shall survive the expiration or termination of this Agreement.
- 10.2 Ownership. All records, reports, documents, and other materials prepared by Individual in performing Services, as well as all records, reports, documents, and other materials containing Confidential Information prepared or generated as a result of this Agreement, shall at all times be and remain the property of the County. All of the foregoing items shall be delivered to the County upon demand at any time and in any event, shall be promptly delivered to the County upon expiration or termination of the Agreement. In the event any of the above items are lost or damaged while in Individual's possession, such items shall be restored or replaced at Individual's expense.

11. **Representations and Warranties of Individual:** Individual represents and warrants that the following shall be true and correct as of the effective date of this Agreement and shall continue to be true and correct during the Term of this Agreement.
- 11.1 **Licensed Professionals.** Services required to be performed by professionals shall be performed by professionals licensed to practice by the State of Illinois in the applicable professional discipline.
- 11.2 **Compliance with Laws.** Individual is and shall remain in compliance with all local, state and federal laws, County of DuPage ordinances, and regulations relating to this Agreement and the performance of Services. Further, Individual is and shall remain in compliance with all County policies and rules, including, but not limited to, criminal background checks.
- 11.3 **Good Standing.** Individual is not in default and has not been deemed by the County to be in default under any other Agreement with the County during the five (5) year period immediately preceding the effective date of this Agreement.

I do not typically charge for the occasional minor non-surgical procedure (ie. Catheter placement, blood draws, microchipping, nail trimming, etc...). If these types of procedures become a regular need and inhibit my ability to perform surgeries, an appropriate charge will be determined and applied.

If I need to officially maintain medical records and controlled substance records, I will charge for this because it requires a lot of time. Otherwise, I can dictate surgical abnormalities or make notes on the cards and the notes can be added to the animal's medical record by someone else.

Prices are subject to change and will be given a 30-day written notice. I reserve the right to discount a charge at my discretion at time of service.

This is an Agreement by and between The County of DuPage and Emergency Telephone System Board of DuPage County, hereafter called SELLER, and Adams County, a public safety entity, hereafter called BUYER.

In consideration of the mutual undertakings herein contained, the parties hereto agree as follows:

BUYER AGREES THAT SELLER WILL IN NO EVENT BE LIABLE FOR DAMAGES ARISING IN STRICT LIABILITY OR FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND, HOWEVER ARISING. SELLER'S LIABILITY SHALL**

UNDER NO CIRCUMSTANCES EXCEED THE PURCHASE PRICE OF SUCH ITEM OF EQUIPMENT SET FORTH IN THIS AGREEMENT.

6. **TITLE:** Title to the Equipment free and clear of all liens, claims and encumbrances of any kind shall vest in BUYER upon final payment by BUYER to SELLER of the full Sale Price required to be paid pursuant to Paragraph 3 hereof.
7. **NOTICES:** Any notice hereunder shall be in writing and shall be deemed to be given when delivered, including but not limited to overnight courier or electronic transmission or, if mailed, on the third day after mailing by registered or certified mail, postage prepaid and addressed to BUYER or SELLER at its respective address shown on the preamble to this Agreement, or to either party at such other address it has designated as its address for purposes of notice hereunder.
8. **FORUM SELECTION, CHOICE OF LAW, AND INDEMNITY:**
 - A. The venue for all disputes arising out of this contract will be exclusively in the circuit court for the Eighteenth Judicial Circuit in DuPage County, Illinois;

BUYER shall, at all times, to the extent permitted by law, fully indemnify, hold harmless, and defend the SELLER and its officers, agents, and employees from and against any and all claims and demands, actions or suits brought against them. BUYER shall likewise be liable for the cost, fees and expenses incurred in the SELLER's defense of any such claims, actions or suits. Notwithstanding this duty to indemnify, the Parties recognize that the DuPage County State's Attorney is the exclusive legal representative of the County of DuPage and the SELLER. Nothing contained herein shall be construed as prohibiting the DuPage County State's Attorney's Office from defending the SELLER, the County, or their officials, directors, officers, agents and employees, from defending through the selection and use of their own agents, attorneys and experts, any claims, suits, demands, proceedings and actions brought against them. Indemnification shall be deemed a waiver of the SELLER or the County of DuPage's defenses under the Illinois Local Government and Governmental Employees Tort Liability Act.
9. **MISCELLANEOUS**
 - A. This Agreement constitutes the entire agreement between SELLER and BUYER with respect to the sale and purchase of the Equipment on Attachment A and supersedes all prior and concurrent offers, promises, representations, negotiations, discussions and agreements that may have been made in connection with the sale of the Equipment. No representation or statement not contained herein shall be binding upon SELLER or BUYER as a warranty or otherwise unless in writing and executed by the party to be bound thereby. If BUYER does not sign this Agreement and return the signed copy of this

Agreement to SELLER within sixty (60) days of the receipt of the Agreement, this Agreement may be voided at SELLER'S election.

- B. BUYER shall not assign its rights under this Agreement unless it has obtained the prior written consent of SELLER. This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and permitted assigns.
- C. This Agreement shall be governed by construed in accordance with the internal laws of the State of Illinois including all matters of construction, validity, performance and enforcement.
- D. This Agreement is subject to acceptance by SELLER at its offices referred to in the preamble and shall only become effective on the date thereof.
- E. No revision or modification of this Agreement shall be effective unless it is in writing and signed by duly authorized officers of BUYER and SELLER.

5. **WARRANTY: SELLER MAKES NO WARRANTY, EXPRESS OR IMPLIED, AS TO THE DESIGN, OPERATION, OR AS TO THE QUALITY OF THE MATERIAL OR WORKMANSHIP IN, THE EQUIPMENT AND ALL WARRANTIES INCLUDING WARRANTIES OF, MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE OF THE EQUIPMENT ARE HEREBY EXCLUDED. BUYER AGREES THAT SELLER WILL IN NO EVENT BE LIABLE FOR DAMAGES ARISING IN STRICT LIABILITY OR FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND, HOWEVER ARISING. SELLER'S LIABILITY SHALL UNDER NO CIRCUMSTANCES EXCEED THE PURCHASE PRICE OF SUCH ITEM OF EQUIPMENT SET FORTH IN THIS AGREEMENT.**

6. **TITLE:** Title to the Equipment free and clear of all liens, claims and encumbrances of any kind shall vest in BUYER upon final payment by BUYER to SELLER of the full Sale Price required to be paid pursuant to Paragraph 3 hereof.

7. **NOTICES:** Any notice hereunder shall be in writing and shall be deemed to be given when delivered, including but not limited to overnight courier or electronic transmission or, if mailed, on the third day after mailing by registered or certified mail, postage prepaid and addressed to BUYER or SELLER at its respective address shown on the preamble to this Agreement, or to either party at such other address it has designated as its address for purposes of notice hereunder.

8. **FORUM SELECTION, CHOICE OF LAW, AND INDEMNITY:**
 - A. The venue for all disputes arising out of this contract will be exclusively in the circuit court for the Eighteenth Judicial Circuit in DuPage County, Illinois;
 - B. This contract shall be governed by the laws of the State of Illinois including all matters of construction, validity, performance and enforcement; and
 - C. BUYER shall, at all times, to the extent permitted by law, fully indemnify, hold harmless, and defend the SELLER and its officers, agents, and employees from and against any and all claims and demands, actions or suits brought against them. BUYER shall likewise be liable for the cost, fees and expenses incurred in the SELLER's defense of any such claims, actions or suits. Notwithstanding this duty to indemnify, the Parties recognize that the DuPage County State's Attorney is the exclusive legal representative of the County of DuPage and the SELLER. Nothing contained herein shall be construed as prohibiting the DuPage County State's Attorney's Office from defending the SELLER, the County, or their officials, directors, officers, agents and employees, from defending through the selection and use of their own agents, attorneys and experts, any claims, suits, demands, proceedings and actions brought against them. Indemnification shall be deemed a waiver of the SELLER or the County of DuPage's defenses under the Illinois Local Government and Governmental Employees Tort Liability Act.

9. MISCELLANEOUS

- A. This Agreement constitutes the entire agreement between SELLER and BUYER with respect to the sale and purchase of the Equipment on Attachment A and supersedes all prior and concurrent offers, promises, representations, negotiations, discussions and agreements that may have been made in connection with the sale of the Equipment. No representation or statement not contained herein shall be binding upon SELLER or BUYER as a warranty or otherwise unless in writing and executed by the party to be bound thereby. If BUYER does not sign this Agreement and return the signed copy of this Agreement to SELLER within sixty (60) days of the receipt of the Agreement, this Agreement may be voided at SELLER'S election.
- B. BUYER shall not assign its rights under this Agreement unless it has obtained the prior written consent of SELLER. This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and permitted assigns.
- C. This Agreement shall be governed by construed in accordance with the internal laws of the State of Illinois including all matters of construction, validity, performance and enforcement.
- D. This Agreement is subject to acceptance by SELLER at its offices referred to in the preamble and shall only become effective on the date thereof.
- E. No revision or modification of this Agreement shall be effective unless it is in writing and signed by duly authorized officers of BUYER and SELLER.
- F. BUYER'S maintenance included under purchasing contract PO 921054 with Motorola includes maintenance under the Motorola System Manager for the length of the contract and service agreements currently in place at the execution of this contract. Upon expiration of the SELLER's contract with Motorola for services, the BUYER may contract for their own services or execute a new service contract with SELLER. SELLER reserves the right to decline the extension of services to a new contract.
- G. BUYER is responsible for arranging maintenance requests through the SELLER's ticketing system.
- H. The BUYER further agrees that any options which are integrated as part of the subscriber units including but not limited to SmartLocate, SmartConnect, SmartMessaging or Airtime are the responsibility of the BUYER.
- I. The BUYER understands that purchase of equipment does not entitle BUYER to access to the DuPage Emergency Dispatch Interoperable Radio System (DEDIR System). Access to the DEDIR System may be granted through a different application request.

IN WITNESS WHEREOF, the parties have caused this Agreement to be executed and do each hereby warrant and represent that its signatory whose signature appears below has been and is on the date of this Agreement duly authorized by all necessary and appropriate corporate action to execute this Agreement.

If this Agreement is not executed by both parties and returned to SELLER within sixty (60) days of receipt, SELLER may terminate this Agreement without notice.

**AMENDMENT 1 TO CONTRACT 23-064-SHF
MASTER SERVICES AGREEMENT**

This Amendment #01 (“**Amendment**”) entered into as of the date signed by all parties listed in this preamble and effective as of April 1, 2026 (“**Amendment Effective Date**”), and amends and revises that certain **Contract 23-064-SHF Master Services Agreement** dated December 13, 2023, as amended from time to time (the “**Agreement**”), by and between Global Tel*Link Corporation d/b/a ViaPath Technologies with an address of 3120 Fairview Park Drive, Suite 300, Falls Church, Virginia 22042 (the “**Bidder**” or “**Company**”), and the County of DuPage, Illinois with an address of 421 North County Farm Road, Wheaton, Illinois 60187-3978 (the “**County**” or “**Premises Provider**”) (Company and Premises Provider collectively, the “**Parties**” and each a “**Party**”). All capitalized terms not defined herein shall have the definitions set forth in the Agreement.

WHEREAS, pursuant to the 2025 FCC Order, no compensation shall be payable to the Premises Provider for IPCS audio or video communications services under this Agreement. However, the 2025 FCC Order authorizes the addition of a Facility Cost Rate Additive to the per-minute cost of IPCS communications to recover costs reasonably incurred by the Premises Provider in making IPCS available.

NOW, THEREFORE, in consideration of the promises and covenants set forth in this Amendment, and for good and valuable consideration, the sufficiency of which is acknowledged by the Parties’ signatures, the Parties agree as follows:

1. General Provisions

1.1. *Section 2 Duration of This Contract and Exhibit A Master Services Agreement, Section 3 Term* of the Agreement is hereby amended as follows:

The Parties agree that the term of the Agreement shall be extended for two (2) years from October 19, 2027, through October 18, 2029.

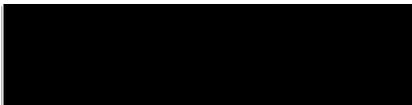

AGREEMENT BETWEEN THE COUNTY OF DUPAGE
AND LOAVES & FISHES COMMUNITY SERVICES
FOR FUNDING ITS HUB 2.0 EXPANSION

WHEREAS, the County of DuPage ("County") is a body corporate and politic; and

WHEREAS, Loaves & Fishes Community Services ("L&F") is an Illinois 501(c)(3) not-for-profit corporation located at 1871 High Grove Lane, Naperville, DuPage County, Illinois 60540, providing healthy food distribution and impactful programs to promote self-sufficiency to the residents in the Chicagoland area, including DuPage County; and

WHEREAS, L&F operates its Hub Facility at 580 Exchange Court, Aurora, DuPage County, Illinois 60504 ("Hub Facility"); and

WHEREAS, the County and L&F are hereafter sometimes referred to as the "Party" and collectively referred to herein as "the Parties"; and

WHEREAS, L&F seeks funding for its construction project ("Project") which will expand its Hub Facility and increase its capacity to serve individuals experiencing food insecurity; and

WHEREAS, the Parties have prepared this Agreement to govern the distribution of the funds identified above ("Agreement").

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the Parties hereby agree as follows:

1. **Purpose of the Agreement.** The purpose of this Agreement is for the County to provide funding for the Project. This Agreement provides payment for eligible expenses as authorized in Section 2 and provides a process for reporting on the Project.
2. **Eligible Uses.** Funds appropriated by the County Board for disbursement under this Agreement shall be used for costs directly related to the design, development, construction and completion of the Project. Said funds shall be utilized only for the following:
 - i. A building addition to L&F's Hub Facility of approximately thirty-two thousand square feet (32,000ft²).

- ii. The interior finishes, racking, equipment, and other furnishings related to the building addition of the Hub Facility.
- 3. **Recitals.** The recitals to this Agreement are incorporated as though set forth fully herein.
- 4. **Term.** This Agreement shall begin on the date of countersignature ("Commencement Date"). Sections 5, 7, 8, 9, 10, 11, 13, 14, 15 and 16 of this Agreement shall remain in effect until December 31, 2028, and shall survive the termination of this Agreement.
- 5. **Payment.** The County agrees to reimburse L&F in an amount not to exceed \$2,500,000.00 for eligible expenses as authorized in Section 2. Reimbursement is contingent upon L&F submitting a fully executed agreement and an updated W-9. L&F shall submit reimbursement requests via the County's online portal. Requests must include backup documentation for itemized expenses, which may include but not be limited to: invoices, receipts, check copies, or other proof of payment. L&F represents that it has performed a competitive bid process for selecting the general contractor for construction of the Hub Facility.
- 6. **Termination.** Upon thirty (30) calendar days' written notice of intention to do so, either party may terminate all or part of the Agreement. The County, by written notice, may immediately terminate all or any part of the Agreement upon determination that the funds have been used, or are being used, for purposes other than those authorized in Section 2.
- 7. **Venue and Applicable Law.** The exclusive venue for disputes arising from this Agreement shall be the 18th Judicial Circuit Court, sitting in Wheaton, DuPage County Illinois. This Agreement shall be governed by the laws of the State of Illinois.
- 8. **Report to the County.** L&F shall report annually on performance before and after Project completion based on L&F's fiscal year ending June 30th. Said report shall include, but not be limited to: (i) the total number of people served broken down by county; (ii) the average number of people visiting per week; and (iii) the average number of visits per household per year. L&F shall submit its report via the County's online portal no later than September 30th each year. Said reports shall commence in 2026 and end in 2030.
- 9. **Audit.** L&F agrees to retain and provide access to all financial records and documents related to the funds for a period of seven (7) years for local, state and federal audit purposes.

10. **Review of Operations.** The County may monitor and conduct an evaluation of operations funded. An evaluation may include a visit from County personnel to review all financial records pertaining to the Project.
11. **Assignment.** Neither Party shall assign performance under this Agreement, nor shall either Party transfer any right or obligation under this Agreement without the express written approval of the County.
12. **Amendment.** Any amendment to the terms of this Agreement must be in writing and will not be effective until it has been executed and approved by the same Parties who approved and executed the original Agreement or their successors.
13. **Waiver.** If the County fails to enforce any provision of this Agreement, that failure does not waive said provision or the County's right to enforce it.
14. **Sole Agreement.** This Agreement contains all negotiations between the County and L&F. No other understanding regarding this Agreement, whether written or oral, may be used to bind either Party.
15. **Authority.** By signing this Agreement, signers represent that they have the authority to enter into this Agreement on behalf of the respective parties.
16. **Indemnification.** L&F shall indemnify, hold harmless and defend the County, its officials, officers, agents, and employees from and against all liability, claims, suits, demands, proceedings and actions, including costs, fees and expense of defense, arising from, growing out of, or related to, any loss, damage, injury, death, or loss or damage to property resulting from, or connected with, L&F's negligent or willful acts, errors or omissions or any of L&F's contractor's or agent's negligent or willful acts in the construction related to the Project or this Agreement.

Dear DuPage County Board,

On behalf of Loaves & Fishes Community Services, we respectfully request \$2.5 million in support of our Hub 2.0 expansion, a strategic infrastructure investment that will strengthen the charitable food system, expand access to healthy food, and increase our ability to serve residents across DuPage County.

Growing Community Need

The need is urgent and growing. Feeding America data shows that food insecurity in DuPage County has increased 64% since 2019, and reductions in SNAP benefits and other public supports are expected to place even greater strain on household budgets. In response, Loaves & Fishes has expanded service through our hub and spoke model, increasing the number of DuPage County residents served by 73% over the past four years. Today, we serve nearly 4,000 DuPage County residents each week. In fiscal year 2025 alone, we served 15,363 unique DuPage County residents through 175,110 total visits.

At the same time, the local charitable food system is operating at full capacity. Cold storage is especially limited, restricting the ability of local pantries to accept and distribute essential perishable foods such as produce, dairy, and protein. Without additional infrastructure, the system cannot keep pace with rising need.

The Hub 2.0 Expansion

Hub 2.0 is the next phase of Loaves & Fishes' proven regional hub and spoke model. The project will expand our Aurora Food Distribution Hub in DuPage County from 30,000 to 62,000 square feet, nearly quadruple cold storage capacity, and more than double the number of clients we can serve directly. The total project cost is \$8 million, building on the success of our current Hub facility and bringing the cumulative investment in this infrastructure to approximately \$12.5 million.

Benefits to DuPage County

This expansion will directly benefit DuPage County by:

- Adding critical infrastructure to serve significantly more residents
- Expanding collaboration across the charitable food system and increasing shared capacity

- Supporting additional spoke locations in underserved areas
- Reducing cost per client through scaled operations and shared logistics
- Providing no-cost cold storage and dry storage access to partner pantries

A Strong Return on Investment

Hub 2.0 is a strategic and cost-effective investment in DuPage County's infrastructure to address food insecurity. DuPage County's proposed investment of \$2.5 million represents approximately 20% of the total cumulative Hub investment, while DuPage County residents have accounted for approximately 36% to 41% of all people served over the past three years. In our most recent fiscal year, Loaves & Fishes directly provided approximately \$12 million in food to DuPage County residents.

With Hub 2.0, we will be positioned to at least double the number of people we serve today, significantly increasing that direct community benefit. The expanded Hub will also create added value for the broader charitable food network through shared storage, increased co-buying opportunities, and reduced logistics costs for partner pantries. Together, these efficiencies maximize the impact of public and philanthropic investment and help more families across DuPage County access healthy food.

Conclusion

Hub 2.0 is not simply a building expansion. It is a strategic investment in DuPage County's social infrastructure that will increase efficiency, strengthen collaboration, and ensure more families have access to the healthy food they need to thrive.

WHEREAS, the Parties have prepared this Agreement to govern the distribution of the funds identified above.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the Parties hereby agree as follows:

- 1. Purpose of the Agreement.** The purpose of this Agreement is to provide a process to reimburse the Agency for food, essential commodities, distribution, administration and related operational expenses. With this support, the Agency will be able to distribute produce, protein, dairy products, and essential commodities to food pantry partners in DuPage County.
- 2. Eligible Uses.** Funds appropriated by the County Board for disbursement under this Agreement shall be used to provide reimbursement for food, essential commodities, distribution, administration, and related operational expenses.
- 3. Recitals.** The recitals to this Agreement are incorporated as though set forth fully herein.
- 4. Term.** This Agreement shall be effective March 24, 2026, through June 30, 2028. Terms relating to indemnification and access to records shall survive indefinitely.
- 5. Termination, Breach.** This Agreement may be terminated upon thirty (30) days' notice to the other Party with the written consent of the other Party. All terms of this Agreement shall be considered material terms and therefore all breaches shall be deemed material breaches. In the event of a breach of this Agreement by any Party, the non-breaching Party shall provide the breaching Party with written notice of the breach and

shall provide a period of not less than thirty (30) days to cure said breach.

- 6. Venue, Applicable Law.** The exclusive venue for disputes arising from this Agreement shall be the 18th Judicial Circuit Court, sitting in Wheaton, Illinois. This Agreement shall be governed by the laws of the State of Illinois.
- 7. Payment.** The County agrees to reimburse the Agency up to \$2,000,000 for food, essential commodities, distribution, administration, and related operational expenses. Total operational and administrative expenses related to the purchase and distribution of food and commodities to local food pantries may not exceed 10% of the total grant amount. Monthly payment is contingent upon the Agency submitting monthly invoices with itemized expenses to the County. Itemized breakdowns shall include a category for administrative and operational expenses. Monthly invoices shall include backup documentation for itemized expenses, which may include, but not be limited to: invoices, receipts, check copies, payroll ledgers, and timesheets.
- 8. Report to the County.** The Agency shall submit monthly performance measure reports to the County. Reports submitted by the 15th of the month shall reflect data through the end of the prior month. Reports shall include, but not be limited to: (1) the amount of food and other essential commodities purchased; and (2) the list of food pantries assisted with estimated value of items provided to each food pantry.
- 9. Review of Operations.** The County may monitor and conduct an evaluation of operations funded. An evaluation may include a visit from County personnel to observe and review the Agency's financial and program materials relating to the activities financed.
- 10. Assignment.** Neither Party shall assign performance under this Agreement, nor shall either Party transfer any right or obligation under this Agreement without the express written approval of the County.
- 11. Amendment.** Any amendment to the terms of this Agreement must be in writing and will not be effective until it has been executed and approved by the same Parties who approved and executed the original Agreement or their successors in office.
- 12. Waiver.** If the County fails to enforce any provision of this Agreement, that failure does not waive said provision or the County's right to enforce it.

13. Sole Agreement. This Agreement contains all negotiations between the County and the Agency. No other understanding regarding this grant Agreement, whether written or oral, may be used to bind either Party.

14. Liability.

(a) The Agency agrees to indemnify, save, and hold the County, its officers, agents and employees, harmless from any claims or causes of action, including attorney's fees incurred by the County, arising from the performance of this Agreement by the Agency, its officers, agents or employees. This clause will not be construed to bar any legal remedies the Agency may have for the County's failure to fulfill any of the County's obligations under this Agreement.

(b) The Agency agrees to indemnify, save and hold the County harmless for any claims arising out of any events, including personal injury or other liability claims, for which the Agency receives reimbursement of any expenses.

15. No Joint Venture or Partnership. The County and the Agency are not partners or joint venturers with each other and nothing herein shall be construed so as to make them such partners or joint venturers or impose any liability as such on any Party.

16. Audit. The Agency agrees to retain and provide access to all financial records and documents related to the funds for a period of seven (7) years for local, state and federal audit purposes.

Dear Chair Conroy and County Board Members.

Thank you for your continued commitment to addressing food-insecurity in the county.

Northern Illinois Food Bank is requesting \$2M to continue the Produce Purchase program for DuPage County member food pantries. This program which was funded by ARPA and then the County Board between 2022 and 2025 enabled us to provide over 5M pounds of fresh produce for food-insecure neighbors in the county through our network of food pantries.

If approved, we would use the \$2M over two years for the same program in which we allocate fresh produce to food pantries for a weekly or twice monthly delivery based on their capacity and the number of neighbors they are serving. This method ensures that the produce is delivered and distributed to neighbors in a timely manner to reduce spoilage and waste. As diligent as we are with getting the fresh produce out as quickly as possible, the nature of the food usually means that there is a small percentage that we have to trash, so we are requesting up to 5% be allowed for trash.

We are requesting 10% of the grant be allocated for administration.

Thank you again for your consideration of this request that will help us meet the increasing need for food and especially for fresh produce to benefit our neighbors.

FOR THE FARM TO PANTRY PROGRAM
IN THE AMOUNT OF \$322,000

WHEREAS, the County of DuPage ("County") is a body corporate and politic; and

WHEREAS, the Conservation Foundation ("Agency") is a 501(c)(3) entity which strives to improve the health of the community and provides safe access to nature; and

WHEREAS, the County and the Agency are hereafter sometimes referred to as the "Party" and collectively referred to herein as "the Parties"; and

WHEREAS, the Parties have prepared this Agreement to govern the distribution of the grant funds identified above.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the Parties hereby agree as follows:

1. **Purpose of the Agreement.** The Purpose of this Agreement is to provide funding for the Farm to Pantry Program. The Farm to Pantry Program will provide locally grown fresh and organic produce to local DuPage County food pantries.
2. **Eligible Uses.** Funds appropriated by the County Board for disbursement under this Agreement shall be used for: (i) the production and delivery of locally grown, fresh vegetables to food pantries across DuPage County; (ii) equipment and supplies needed to increase vegetable production and expand refrigerate storage capacity; (iii) a new refrigerated delivery van to expand deliveries to food pantries across DuPage County; and (iv) the purchase, construction, and related utility costs of a new greenhouse to provide an additional 2-4 weeks of produce in future years.
3. **Recitals.** The recitals to this Agreement are incorporated as though set forth fully herein.
4. **Term.** This Agreement shall remain in effect through November 30, 2027. Sections 6, 7, 8, 9, 10, 11, 13, 14, 15 and 16 of this Agreement shall remain in effect indefinitely and shall survive the termination of this Agreement.

5. **Termination, Breach.** This Agreement may be terminated upon thirty (30) days' notice to the other Party with the written consent of the other Party. All terms of this Agreement shall be considered material terms and therefore all breaches shall be deemed material breaches. In the event of a breach of this Agreement by any Party, the non-breaching Party shall provide the breaching Party with written notice of the breach and shall provide a period of not less than thirty (30) days to cure said breach.
6. **Venue, Applicable Law.** The exclusive venue for disputes arising from this Agreement shall be the 18th Judicial Circuit Court, sitting in Wheaton, Illinois. This Agreement shall be governed by the laws of the State of Illinois.
7. **Payment.** The County shall reimburse the Agency in an amount not to exceed \$322,000 for eligible expenses incurred as defined in Section 2 of this Agreement. The Agency shall invoice the County via the County's on-line portal. Payment is contingent upon prior receipt of a signed copy of this Agreement and an updated Internal Revenue Service ("IRS") W-9 form. For payment, the Agency shall submit invoices accompanied by supporting documentation that may include, but not be limited to, receipts, invoices, bank statements, check stubs, or other proof of payment.
8. **Reports to the County.** Effective June 1, 2026, through November 30, 2027, the Agency shall submit monthly reports to the County. These reports shall use the County's on-line portal for submitting performance metrics. Said metrics may include the number of pounds provided to local food pantries and the average cost per pound.
9. **Audit.** The Agency agrees to retain and provide access to all financial records and documents related to the grant for a period of seven (7) years.
10. **Review of Operations.** The County may monitor and conduct an evaluation of operations funded. An evaluation may include a visit from County personnel to review all financial records pertaining to the program.
11. **Liquidated damages.** The Agency agrees to indemnify the County and hold the County harmless against any and all liabilities, including judgments, costs, and reasonable counsel fees, related to the disbursement of funds to the Agency. The Agency expressly agrees to reimburse the County for the cost of any penalty, fine, or judgment for any improper disbursement of funds under this Agreement.

12. **Assignment.** Neither Party shall assign performance under this Agreement, nor shall either Party transfer any right or obligation under this Agreement without the express written approval of the County.
13. **Amendment.** Any amendment to the terms of this Agreement must be in writing and will not be effective until it has been executed and approved by the same Parties who approved and executed the original Agreement or their successors in office.

15. **Sole Agreement.** This Agreement contains all negotiations between the County and Agency. No other understanding regarding this grant Agreement, whether written or oral, may be used to bind either Party.
16. **Liability.** The Agency agrees to indemnify, save, and hold the County, its officers, agents and employees, harmless from any claims or causes of action, including attorney's fees incurred by the County, arising from the performance of this Agreement by the Agency, its officers, agents or employees. This clause will not be construed to bar any legal remedies the Agency may have for the County's failure to fulfill any of the County's obligations under this Agreement. Notwithstanding any provisions of this Agreement to the contrary, indemnification under Section 11 of this Agreement shall be limited to the Agency's allocation, less any amount unspent pursuant to Section 11 of this Agreement.

Request for funding for Farm to Pantry Initiative

We are requesting funds to expand the Farm to Pantry Initiative by **60 percent** to serve residents in **each of the six DuPage County Districts**, increasing the volume of farm-fresh vegetables reaching those facing food insecurity. Additionally, we are requesting funds to purchase a new refrigerated delivery van to reduce barriers to pantries for receiving fresh vegetables and expand capacity of temperature controlled growing space to extend length of time food can be provided to food pantries.

Funds Requested For:

- **\$80,000/year - \$160,000 total** to provide approximately **800 units (~22,000 pounds)** of truly fresh, pantry-preferred, culturally-familiar vegetables per week during our twenty-week season (mid-June through early November) to pantries serving approximately **5,800 residents** across all six DuPage County districts.
- **\$6,000/year - \$12,000 total** for supplies needed to increase vegetable production by 60% and expand refrigerated storage capacity.
- **\$90,000 in 2026** – New refrigerated delivery van to provide delivery to food pantries across DuPage County.
- **\$60,000 in 2027** – Purchase, construct and run utilities for new greenhouse. This temperature-controlled space would provide an additional **2–4 weeks** of produce in future years.
- **Total over 2 years - \$322,000**

Background:

Farm to Pantry Initiative

The support from DuPage County over the past three years through ARPA and MIP has enabled The Conservation Foundation to launch a reliable, impactful, and highly successful Farm to Pantry Initiative for our neighbors facing food insecurity. Through this partnership, we have helped address the fresh food gap across DuPage County by providing consistent access to fresh, locally grown, organic vegetables to our pantry partners.

To date, our DuPage County Farm to Pantry Initiative has:

- **Provided 10,800 DuPage County residents** with access to truly fresh, locally grown, organic vegetables distributed through local food pantries over the past three growing seasons.
- **Provided over 49,000 pounds** of just-harvested vegetables to pantry partners' clients.
- **Partnered closely with each pantry** to identify the most needed and culturally familiar vegetables for their communities, allowing families to prepare nutritious, familiar meals while supporting pantries in meeting their goals of offering the healthiest food options possible.
- **Ensured rapid distribution**, with pantry clients receiving farm-fresh vegetables within 2–3 days of harvest. Fresh, appealing produce is significantly more likely to be selected, taken home, and consumed—especially by children.
