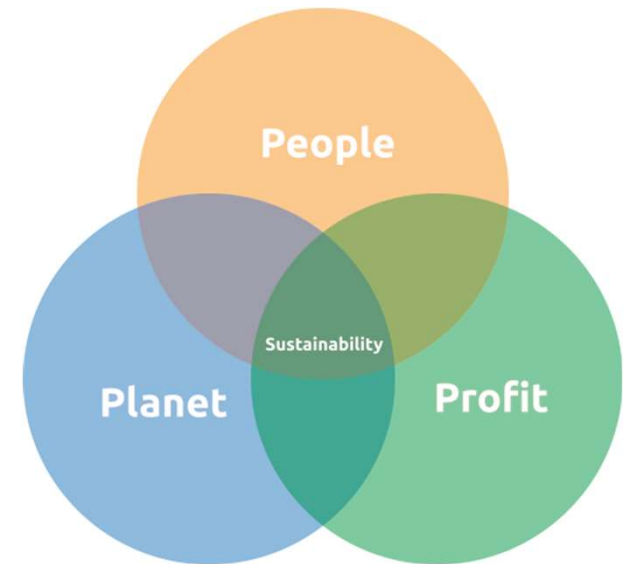

- **CGCC** promotes closing the loop for the circular economy.

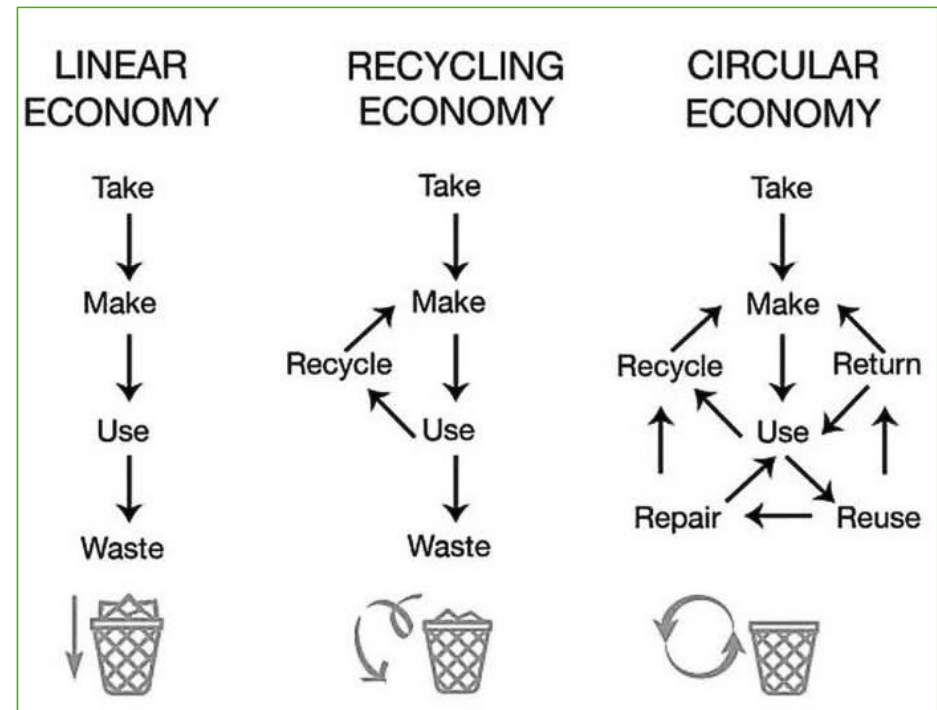

Chicagoland Green Chamber

- Support businesses to identify and overcome the barriers to changing to sustainable practices and products, through training, procurement, new products and services, and resource guides.
- Administer a green business recognition program with a business directory, including one specifically aimed at food establishments.
- Share events, resources, and news in a monthly newsletter

Chicagoland Green Chamber

- Network includes workforce organizations
- Connect all to sustainable funding, rebates, grants, and no cost energy assessments
- Assist schools with finding alternative vendors for food ware and compost waste collection
- Work with local governments across to promote alternatives
 - Heat pump contractor workshops to support the adoption of the Stretch Codes

Chicagoland Green Chamber

Beyond business-to-business promotion

- **Support public agencies** with sustainable product vendors and service contractors
 - Schools
 - Parks and libraries
 - Local governments
- Connect with environmental education / advocacy nonprofits
- **Resources for all** (businesses, public agencies, and individuals)

Chicagoland Green Chamber

- **Work with business chambers** across the region to offer specialized assistance to their members
- **Assist** businesses in complying with or planning for **new laws**

 - **Bring Your Own Container – HB 2086**
 - **Battery Recycling - SB 3686**
 - Polystyrene Foam (Styrofoam) Ban (food ware) – SB 1531
 - Food Waste Diversion – SB 2852
 - Appliance Standards – HB 5366
 - Single-use Plastic Bag Reduction – SB 1872, SB 3742, HB 1146, HB 5112
 - Skip the Stuff – HB 1600
 - Instant Solar Permitting – SB 2395, HB 3265

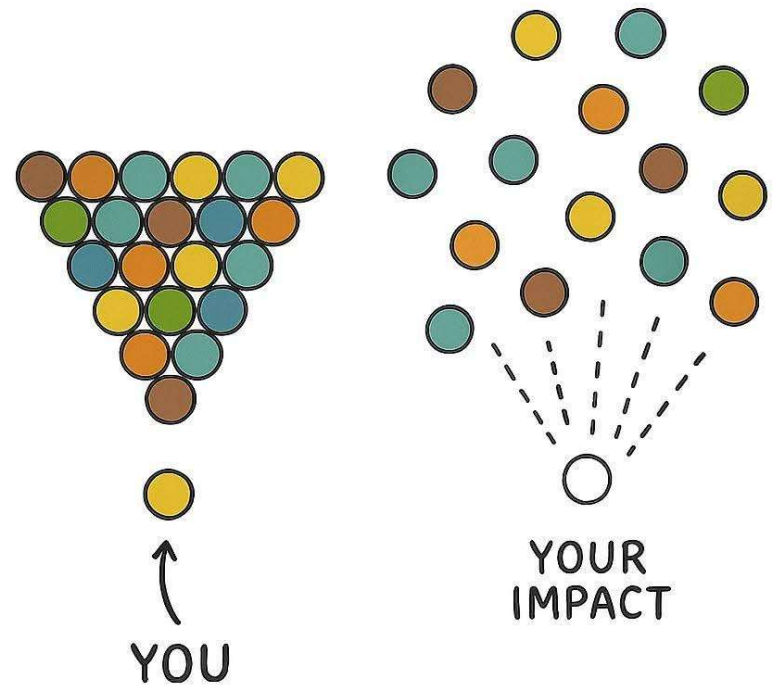
Compostable food ware product examples

Benefits for DuPage County

- **Vendor lists** can assist the County when requesting alternative products and services for facilities operations and management
 - Plastic-free vending machines
 - Cool Seal for parking lots
 - Single-use food ware and food waste diversion for cafeterias
 - Waste upcycling collection boxes
 - Concrete with an Environmental Product Declaration (EPD)
- **Incentives** to save on building equipment
- **Discounts** for services and products

Benefits for DuPage County

• Cafeterias

- Foam food ware, plastic utensils, and straws → switch to compostables for visitors
- Bring Your Own education for employees
- Compost collection bins & Zero Waste Boxes
- Education / signage
- List of vendors and products for bidding



• Construction Materials

- Sustainable concrete with Environmental Production Declarations (EPDs)
- Education on EPDs
- Upcycling waste materials (concrete)
