REQUEST: Special Use for the construction of the new 178,000 square foot highway maintenance facility including the equipment garage, support spaces and DOT offices. Site development also includes construction of the new yard for DOT operations including a new salt storage building, vehicle wash building and fueling island. Additional improvements will be made to the surrounding areas including, new elevator at the current 509 County parking deck with covered walkway, a new prefabricated cold storage building and new public bathroom building, both to be utilized by the fairgrounds.
