#### 7. ADMINISTRATIVE UPDATE

Staff are preparing a construction update video to be shared publicly.

DAF gala ticket sales are currently 200 of the total goal of 500-600 tickets sold. Member DeSart reminded everyone that the event is a benefit for the capital campaign for which we are attempting to raise several million dollars for the new shelter.

Laura added that the DAF gala ticket price is in line with that of other area shelters and rescues. Anyone unable to afford the price of a gala ticket may volunteer for the event or bid on silent auction items remotely. For anyone unable to participate in the gala event, there are other upcoming fundraising opportunities to get involved in, such as Giving DuPage Days.

Member DeSart requested that everyone do what they can to drive ticket sales, sponsorships and big ticket in-kind silent auction items for the gala event (sporting event or concert tickets, memorabilia, etc.). Sponsorship packets are available in the County Board office or at the shelter.

Dog adoptions at the shelter have been terribly slow. Perfect Match fee-waived dog adoption promotion is in place through the end of February.

Staff are in the process of planning several summertime vaccine and microchip clinics with Hinsdale Humane Society, including one specifically geared toward veterans.

Staff are in the process of planning for the 2024 Specialty Veterinary Vehicle season, including planning for a few potential pre-season dates in response to the unseasonably warm winter.

Another free police department training is being planned for this year featuring our own content and DCAS educator to make it more relevant to DuPage County municipal partners. Last year's police department training was very successful. PDs were outfitted with animal supplies, microchip scanners, etc. It is our goal to be able to provide similar resources again this year.

The shelter population is currently around 100 animals. This is due in part to the time of year and also in part due to our population management practices in place to help staff navigate the disruptions caused by construction.

Member DeSart shared that NBC5 reporter Regina Waldroup had agreed to emcee the DAF gala event on April 12th. Regina is an avid animal lover and speaks at/supports animal-related causes.

## 8. OLD BUSINESS

Chair Krajewski mentioned that suggested language updating animal ordinance would be coming soon from ASA Prindle. Proposed amendments included changes to pricing for select services and feeding of wildlife.

## 9. **NEW BUSINESS**

Member Rutledge commented on Willowbrook Wildlife's current policy on raccoons.

## **3. PUBLIC COMMENT**

Max Lecaros, DuPage Animal Friends Board President, shared details about the DAF fundraising gala "Raise the Woof" on April 12, 2024 at Abbington Banquets. The event goal is to sell 600 tickets and raise \$450,000 for the shelter capital campaign. The night will feature a dinner, open bar, silent auction, live auction, dueling pianos, and other activities. Sponsorships are available and tables and tickets are currently available for purchase. Member Krajewski would like to see each county board member purchase a table at the gala. Laura is open to meeting with each county board member and/or potential donor to discuss ways in which they can support the gala and capital campaign fundraising goals.

## 4. CHAIRMAN'S REMARKS - CHAIR KRAJEWSKI

Chairman Krajewski informed the committee that an amendment will be made to the FY2024 Animal Services budget to allow for the addition of a new headcount. The additional staff member will make it possible for Laura to delegate more administrative duties so that she has the bandwidth available to assist the DAF board and fundraising committee as they work toward their aggressive capital campaign goals. FY2023 Animal Services revenue exceeded budget expectations and the same is expected for FY2024.

Laura added that the change order for the increase to the RWE Design contract for the shelter renovation approved at the November meeting will also be included in the upcoming FY2024 budget amendment.

## 8. ADMINISTRATIVE UPDATE

Construction is underway and moving quickly. Two structures are now up: the Real Life Room and the vet vehicle garage. Metal roofing is also being installed.

Summary - Draft

Year-end Statistics: 2022 saw an 89% year end Live Release Rate. Even after such a challenging year, Animal Services closed 2023 with a record high 92% Live Release Rate. To be considered a no-kill shelter, a 90% Live Release Rate is the benchmark. Laura pointed out that while it is our goal to re-home as many animals as possible, our goal is to always make public safety a priority while also taking into consideration each animal as an individual.

12% of cats and 57% of dogs were successfully returned to their owners in 2023. We are hopeful that microchip clinics and efforts to train and arm municipal partners with microchip scanners have made a positive impact.

The shelter went into 2023 with a starting population of 127 animals. 2,155 animals were taken in during the year. Ending shelter population was 66 animals. The shelter is still maintaining a low shelter population due to disruptions caused by construction. Conversation continued regarding efforts to divert intakes into area shelters and rescues, as well as creative ways to utilize space in the existing shelter until construction is completed.

A Senior Account Clerk has been hired to, among other tasks, work directly with veterinary partners to complete unused 2023 tag return and resolve open accounts receivable balances. An Administrative Specialist posting will be up soon to replace the position recently vacated.

Laura told a story of a recent capital campaign donor who adopted from several area shelters, but did not have an interaction with Animal Services in the past ten years. This donor has witnessed DCAS's efforts to do our best to support the community and its animals. With so many worthy organizations, their family felt it was important to support our open admission efforts to provide a safe place to land for animals of all species, under all circumstances. We are heartened by this donor's generous support and the support of all who see our efforts to serve the people and the animals in our community.

## ACCEPTANCE AND APPROPRIATION OF THE DUPAGE ANIMAL FRIENDS UNRESTRICTED GRANT PY24 COMPANY 5000 - ACCOUNTING UNIT 1310 \$50,000

(Under the administrative direction of Animal Services)

WHEREAS, the County of DuPage has been notified by DuPage Animal Friends that grant funds in the amount of \$50,000 (FIFTY THOUSAND AND NO/100 DOLLARS) are available to be used for the unrestricted program needs of DuPage County Animal Services; and

WHEREAS, to receive said grant funds, the County of DuPage must enter into an agreement with DuPage Animal Friends, a copy of which is attached to and incorporated as a part of this resolution by reference (ATTACHMENT II); and

WHEREAS, the term of the grant award is from December 1, 2023 through November 30, 2024; and

WHEREAS, no additional County funds are required to receive this funding; and

WHEREAS, acceptance of this grant award does not add any additional subsidy from the County; and

WHEREAS, the DuPage County Board finds that the need to appropriate said funds creates an emergency within the meaning of the Counties Act, Budget Division, (55 ILCS 5/6-1003).

NOW, THEREFORE, BE IT RESOLVED by the DuPage County Board that the agreement between the County of DuPage and DuPage Animal Friends is hereby accepted; and

BE IT FURTHER RESOLVED by the DuPage County Board that the additional appropriation on the attached sheet (ATTACHMENT I) in the amount of \$50,000 (FIFTY THOUSAND AND NO/100 DOLLARS) be made to establish the DuPage Animal Friends Unrestricted Grant PY24, Company 5000 - Accounting Unit 1310, for the period of December 1, 2023 to November 30, 2024; and

#### RE: Unrestricted Grant for \$50,000

Dear Laura:

**Program Grant**. DuPage Animal Friends (DAF), formally known as Friends of DuPage County Animal Care and Control Foundation, has approved a one-time unrestricted grant to DuPage County Animal Services (DCAS) of \$50,000 for the fiscal year beginning 12/1/2023-11/30/2024.

**Grant Purpose and Expenditure of Funds**. These funds are unrestricted but should be used solely for the purposes of supporting the mission of DuPage Animal Friends. DCAS is responsible for the active prioritization and management of granted funds.

DCAS agrees to not use any of the grant, or the interest or income thereon, to conduct tests for public safety, to influence any legislation or the outcome of any election, to conduct a voter registration drive, to satisfy a charitable pledge or obligation of any person or organization, or to provide any tangible economic benefit to any substantial contributor, or their respective family members.

**Unused Funds Grant Within the Fiscal Year.** Any unused funds should be carried by DCAS into the next fiscal year beginning 12/1/2024 and reported to DAF prior to proceeding with the finalization of the next fiscal year grant beginning 12/1/2024.

**Grant Payment**. DAF will promptly send the grant funds upon receipt by DAF (addressed to the person signing this letter on behalf of the DAF) of a countersigned copy of this letter.

**Reporting**. Refer to DAF Grant Funding Methodology dated August 20, 2018 for reporting requirements.

DAF's Public Reports. DAF may include information on this grant in its periodic public reports.

**Recognition**. If you publicize this grant, please list it as a donation from "the donors of DuPage Animal Friends" or "DuPage Animal Friends."

**Other Terms**. This grant is subject to these Terms and Conditions and by countersigning this letter and/or by cashing the grant check, you are indicating that you agree to its terms. Nothing contained in this grant letter shall be deemed to create a joint venture, partnership relationship, or employer/employee relationship between DAF and DCAS.

**Counter Signatures**. This instrument may be executed in counterparts, each of which shall be deemed an original, but all of which shall constitute one and the same instrument.
