Overview

Medical Services consisting of mobile veterinary services to include high-volume spay/neuter and outreach veterinary services for rescue partners and the public; and backup veterinary services for DCAS from March 1, 2025-November 30, 2025. All services included in this contract are funded via unrestricted grant from DuPage Animal Friends (5000-1310).

JUSTIFICATION Summarize why this procurement is necessary and what objectives will be accomplished

The mobile veterinary program utilizing Dr. Turner enables DCAS to meet the community's needs by: performing high volume targeted spay/neuter surgeries thus decreasing the number of unwanted cats and dogs in and around DuPage County; providing affordable veterinary services and programs for at-risk pets with the aim of keeping the pet with their owner/caretaker and thus preventing the animal from entering the shelter system; and providing emergency disaster veterinary response services for natural and man-made disasters. This contract also makes it possible to maintain a high level of care for DCAS shelter and foster animals by providing backup veterinary services with a veterinarian experienced in shelter medicine - specifically shelter medicine at DCAS. Dr. Turner is familiar with DCAS's medical protocols and procedures, has direct experience performing high volume spay/neuter on the specialty veterinary vehicle, and has reliably provided backup veterinary support at the DCAS shelter since fall 2022.

SOURCE SELECTION	Describe method used to select source. There are a limited number of veterinarians in the Chicagoland area that are experienced in high-volume surgeries on a mobile vehicle where the working conditions are significantly different than a typical veterinary clinic setting. Additionally, there are only a select few veterinarians that are experienced in high volume feral cat spay/neuter and shelter medicine. The department has consulted with other veterinarians and has made attempts to recruit and train new veterinarians in this area, but availability and interest continues to be very low. Securing veterinary support has and continues to be a challenge for DCAS. Dr. Turner has proven to be very effective and efficient in performing high-volume spay/neuter and provides a high quality of veterinary care. In addition, Dr. Turner has proven to be reliable, flexible, and works very well with the DCAS staff. Since he began providing veterinary services in 2022, Dr. Turner has spayed/neutered more than 1,000 felines as part of DCAS's mobile spay/neuter program, and has performed surgeries, vaccines, and exams on hundreds of shelter animals.
