## **Deputy Fire Chief** (01/18 to 04/23)

Responsible for the overall operations of the department. Provides administrative and operational support to the Fire Chief, to ensure the readiness of Fire/Rescue to respond to and control emergencies when required and directs activities at emergency scenes.

- Assists the Fire Chief in planning, administration, coordination, direction and review of Fire Department operations and activities
- Serves as Acting Fire Chief in the absence of the Fire Chief
- Develops, manages and monitors the Fire and Rescue portion of the Fire Department budget
- Provide leadership and mentoring to the 3 shift Battalion Chief's
- Assists in updating policies, procedures and SOG's
- Oversees the operational budget, coordinates budget allocations and assists in strategic planning for the department
- Represent the department at conferences and at meetings as a member of multiple Fire Chief organizations

## Battalion Chief / Paramedic (09/12 to 12/17)

Responsible for the supervision and operation of 3 pieces of fire apparatus equipment and 3 ALS ambulances, 21 personnel and shift lieutenants at two stations (#44 and #45), serving on a shift rotation (24x48), performing a variety of supervisory, administrative, and technical work in the supervision and administration of fire suppression, emergency medical service, hazardous materials, specialized rescue, and fire prevention activities of a fire battalion responding to 6409 calls per year (75% of calls are EMS related)

- Performs command and control functions at incidents including mass casualty, structure fires, vehicle accidents, and EMS occurrences
- Handles duties associated with personnel management, including mentoring, discipline, training, and coaching
- Provides instruction/ supervision during high risk training and multiple company operations
- Plans and coordinates non-emergency activities including staffing assignments, training, fire inspection, and special duty assignments
- Collaborates in managing the battalion through the development, administration, and implementation of departmental policies, rules, regulations, standards of operation, budget plans, and goal setting
- Evaluates training needs of subordinate personnel and plans, schedules, presents and supervises the presentation of training and drills
- Supervises Fire Lieutenants in the maintenance of buildings, vehicles, and equipment at the fire stations and assigns company members to daily maintenance activities
- Maintains comprehensive records of station activities and enters in station log information documenting daily activities, including alarm response, training activities, and station needs
- Serves as the department's clothing officer; approves all uniform purchases for the department members; in 2015 selected a new uniform vendor and implemented an entirely new purchasing process for the department
- Advises the Fire Chief and Assistant Chief on the adoption of firefight procedures, rules, and regulations
- Represents the department at various meetings
- Assists HR with internal investigations, grievance investigations, firefighter hiring interviews and contract negotiations
- Participates in the department's annual toy parade where we collect toys in December that are distributed through an organization for underprivileged children

## Lieutenant/Paramedic (11/00-09/12)

- Performed first level managerial tasks and skilled firefighting work involving the command of Fire Company in firefighting and emergency response situations
- Served as Acting Shift Commander, supervising and coordinating activities and operations of multiple company of firefighters and ambulance personnel, ensuring emergency response readiness
- Set up command post at fire or accident scenes; directed placement of equipment and overall attack on fire, including laying of hose lines, the direction of water streams, the placement of ladders, the ventilating of buildings, the rescue of persons, and the cleaning of premises after fire has been extinguished or accident and victims have been removed
- Ensured that the assigned training from the Training Division was completed by our personnel
