4. CHAIRMAN'S REMARKS - CHAIR KRAJEWSKI

Foundation Coordinator Jillian shared that 2026 DAF fundraising calendars are now available for sale. Calendars are \$20 each or \$25 if shipped. Chair Krajewski shared that Jillian's position was created to assist DAF board with fundraising, she has also taken on the role of managing social media and marketing for the shelter. The new Marketing Coordinator position will be a full-time grant-funded position. The person in this role will assume responsibility for all marketing and social media so that the Foundation Coordinator can focus on fundraising and relationship-building. In addition, the Marketing Coordinator will assist with animal photography, website content management, and fundraising events.

7. **ADMINISTRATIVE UPDATE**

Laura shared that shelter population is still high, with no slow-down in cat intakes. Kittens are continuing to arrive, and Feral Fixers has ceased trapping for the winter. Laura stated there is currently an open position for a full-time second shelter veterinarian. Once filled this position will focus primarily on cat spay/neuter.

Shelter population is currently 265 animals, 216 of which are cats. A cat fee-waived cat adoption event is planned for Saturday, November 22nd in the hopes of moving more cats into homes.

A Home for the Holidays adoption will begin the week of November 24th and will include waived adoption fees on select animals.

There are several new hires in the process of being on-boarded. A new Animal Control Officer started on the 17th. They have experience working with wildlife which will be useful as Animal Services assists with sick and injured wildlife in unincorporated parts of DuPage County. Chair Krajewski reminded the committee that incorporated parts of the county are responsible for handling sick & injured wildlife calls in their own jurisdictions.

Laura shared that officers recently assisted with rescuing a sick coyote in unincorporated West Chicago. The coyote is currently being cared for by DuPage Conservation Center and per the last update, it is doing well. Staff are hopeful he will recover well enough to be released back into the wild.

Two new Client Services team members are set to have their first day the first week of December, and a new Animal Caretaker will be starting next week.

8. OLD BUSINESS

Chair Krajewski announced that the DAF gala will take place on May 15, 2026 at the Chicago Marriott Oak Brook.

A family that adopted a dog from the shelter will be hosting a fundraiser to benefit DAF on September 19, 2026 at Hotel Arista. The fundraising goal for this event is \$200,000.

The DAF board has set an annual fundraising goal of \$700,000 beginning in 2027, to help fund capital loan repayment, the grant-funded Marketing Coordinator position, annual unrestricted grant to Animal Services, and ongoing specialty/emergency medical needs.

9. NEW BUSINESS

Member DeSart suggested that Animal Services partner with food insecurity organizations to drive pet food donations for families with pets that are in need of assistance.

Chair Krajewski shared there is a joint event planned for December 6th hosted by the cities of Downers Grove, Westmont and Hinsdale to benefit Hinsdale Family Shelter, Downers Grove FISH, and People's Resource Center. Inspired by the sheer number of animals being surrendered to shelters due to financial hardship, the event will drive donations of pet and people food to these organizations that serve community members in need. A top ten list of most needed food donations will be available soon. The most needed pet food is currently canned cat food.

Laura shared the food donations received at the shelter that cannot be used at the shelter are always shared with community members in need, rescue partners, and local food pantries.

Member Eckhoff proposed an annual award given in recognition of a community member that has demonstrated exceptional care and given to animals. Joan shared that this year's Daily Herald "Someone to be Thankful For" will feature an Animal Services volunteer. It was suggested that recognition start with email and social media mentions, culminating in a grand award presented at the DAF gala.

8. ADMINISTRATIVE UPDATE

Laura shared current animal population stats: current population is 248, of which 181 are cats. Cats continue to present space challenges. Animal Services will be targeting spay/neuter resources at cats to help reduce unwanted litters and slow the flow of cats into the shelter system.

Requests for owner relinquishment continue to come in, as do the number of cats found outdoors. The most common reason for cat relinquishment is financial hardship, often combined with other personal circumstances.

Staff are discussing ways of getting supplies and medical care resources into the community but the problem is so pervasive and growing so quickly that need is far out-pacing available resources.

Intake has been significant so far this year. 1,848 animals were admitted in all of 2024. Intake for 2025 year to date is already above 2,200 animals. The majority arrived as strays from the public or municipal partners. 846 are owner relinquished animals.

Animal Services hosted a very successful free vaccine/microchip clinic on September 8th. Lines were so long that several clients had to be turned away at the end of the night with a voucher to be redeemed for free vaccines/microchip at a later date. More than 180 animals were vaccinated and microchipped during the event on Sept. 8th with another 25 event vouchers redeemed post event.





DuPage Animal Friends is a 501(c)3 charity that supports operations at DuPage County Animal Services. It is an all volunteer organization that works closely with DCAS leadership. An increase in workload has made it challenging for the all volunteer board and Foundation Coordinator to keep up with daily marketing and social media tasks. The need for a full time marketing coordinator was identified in 2025. This grant to DCAS is intended for DCAS to hire and manage this position so that the Foundation Coordinator can focus on key tasks related to fundraising and relationship building. Because the total grant amount exceeds the total cost of annual salary and fringe benefits, any remaining unused funds will be carried over into FY27 to continue funding the position.

COMMUNITY WELL-BEING: This position will allow Animal Services to stay in constant communication with community members and stakeholders. Through regular marketing and communications, DCAS will be able to share challenges, successes, needs, and impact. Doing so will ideally help prevent animals from entering the shelter system, while increasing positive outcomes for animals that do enter the shelter. **FISCAL RESPONSIBILITY:** By educating the community on the importance of vaccinating pets for rabies and by educating veterinarians on the importance of promptly reporting vaccines administered, DCAS will increase the number of licensed pets in the community.
