Recommendation for approval of Change Order #7 to Motorola Solutions, Inc. PO 921054/5522-1 to provide additional portable and mobile radio units and accessories to augment the original equipment order to be used on the DuPage Emergency Dispatch Interoperable Radio System on STARCOM21. This purchase will also upgrade the APX4000 radios in the DuPage Sheriff's Office and for Agencies' Community Service Officers. The total amount of capital costs is \$4,870,737.99 for a new contract total of \$42,281,102.42.

The procurement of replacement portable and mobile radios was approved by the ETS Board on November 10, 2021. Motorola is fulfilling a final change order for additional portable equipment at the 47% discount negotiated in 2021.

Agencies have been submitting tickets for additional equipment based on their headcount and vehicle changes. This purchase will also include the ETSB cache. The APX4000s were end of life in 2024 and will be end of support in 2030. To upgrade the APX4000s in the DEDIR System, the following quantities would be ordered:

248 Sheriff's Office - County Cost

- 15 OHSEM (Security) County Cost
- 8 Probation County Cost
- 1 State's Attorney's Office County Cost
- 82 Agency APX4000s now covered by ETSB qty 82 ETSB Cost

This purchase order is made through the IL State Master Contract 24302 - STARCOM21, IL CMT2023269.
