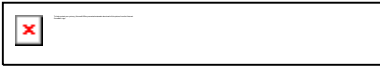

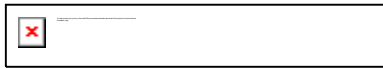

Thank you so very much for taking up this vote once again. It is truly amazing. Thank you. Nicki

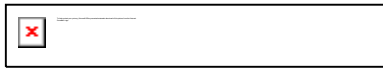

I am tired of politicians wringing their hands when these tragedies happen. For the love of God. ACT.

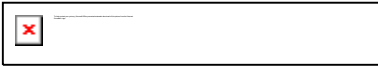

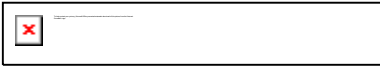
Subject: Safe storage resolution
