On behalf of ALMAS, I am here to express our deep concern about recent reports of armed and masked ICE agents operating on or near county property without visible identification or judicial warrants. Such actions create fear and confusion across our communities: among parents taking their children to school, workers commuting to their jobs, and business owners serving local customers. This fear undermines public safety and erodes the trust that residents should have in local government and law enforcement. DuPage County has long been recognized as a place of opportunity, safety, and strong civic values. That reputation depends on transparency and accountability. We respectfully ask this Board to seek clear answers to the following: Why was ICE operating on county property without a warrant? What safeguards ensure that the Sheriff's Office upholds state law and protects all residents equally?</p> <p>And how are surveillance technologies, such as drones and Flock cameras, being used and governed to protect privacy and civil rights? These questions are not about politics; they are about important principles: fairness, dignity, and the rule of law. DuPage residents deserve the assurance that county resources are never used to enable unlawful enforcement actions or intimidation.</p> <p>We urge this Board to take the following actions: Request and publicly release a full explanation from the Sheriff's Office regarding the presence and activities of ICE agents on or near county property. Establish a clear policy guidance that county resources, personnel, and surveillance technologies will not be used to support civil immigration enforcement, in alignment with the Illinois TRUST Act and Way Forward Act. Convene a public community briefing where residents, legal advocates, and county leadership can receive answers and engage in transparent dialogue. These are necessary steps to rebuild trust, ensure accountability, and protect the safety and dignity of all DuPage County residents. Thank you.</p>
