

## TERMS AND CONDITIONS

**Term.** This Order will be made effective as of the Effective Date above and will continue for an initial term of 36 months. This Order will then renew automatically for successive 1 year periods after the initial term unless written notice is provided to Trintech at least 90 days prior to expiration.

**Payment Terms and Billing.** Subscriber will pay Trintech all fees subject to Section 3 of the Agreement upon receipt of an invoice.

**Annual Subscription Fees.** All annual subscription fees in this Order are paid in advance. Trintech will provide the initial invoice to Subscriber for the first year of annual subscription fees upon execution of this Order. Trintech will invoice Subscriber for all annual recurring fees prior to each anniversary of the Effective Date of this Order thereafter. After the Initial Term, annual fees will increase by the lower of CPI or 5%.

**Matcher Transaction.** For the Adra Matcher component, Subscriber will be charged USO 0.061479 per transaction for any amounts in excess of the quantities purchased in the table above, unless additional transactions have been purchased in a Change Order.

**Changes.** Subscriber will be committed to the annual subscription fees and quantities above for the initial term of this Order. Subscriber may add additional Users at the prices herein provided that Subscriber will be responsible for the subscription fees for such Users for the remainder of the initial term. Trintech will bill Subscriber the annualized, prorata amount for such additional User quantities added by Subscriber.

**Services.** Services will be performed in a professional and workmanlike manner and based on industry standards.
