The Contractor shall provide training and/or demonstrations of their online ordering system to County personnel upon request. Upon request the awarded Contractor shall provide electronic proofs to the County for review and approval.

The Order Delivery Schedule shall be:

- Standard – Reorders and/or no revisions required.
 - Forms to be delivered 7 to 10 business days from order submission date.
- Custom – Newly designed or revisions required.
 - Forms to be delivered within 10 to 15 business days from order submission date or otherwise mutually agreed upon delivery timeframe.

The Contractor shall ensure:

- NCR forms are shrink wrapped in reams applicable to multi-part count and boxed for shipping.
- Acceptance of returned poor quality printing and/or forms, which shall be reprinted at no additional cost.

The County shall provide digital and non-digital artwork, including signature files, to the awarded Contractor in electronic (e.g., Adobe PDF and/or MS Office) format.

SUPPORT SERVICES

In addition to the furnishing and delivery of NCR forms, the Contractor shall provide the following services upon request:

- Artwork and logo creation.
- Form design.
- Sequence/crash numbering.
- Hole punching.
- Add one additional ink (i.e., 3rd color).
- Tab top finishing.
- Replacement of last page/part with 7.5pt. White CF Tag.
- Increase NCR stock to print Legal size (e.g., 8.5" x 14") documents.
- Add on additional part/page.
- Add double side, single ink print.

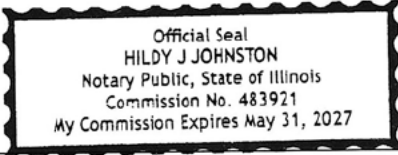
