My name is Helen. I'm here because public safety cannot come at the cost of

public trust. Drones.

The Sheriff's new drone policy allows powerful surveillance technology with minimal transparency. We know that drones can be lifesaving in search-and-

rescue missions. But without detailed written procedures for their use, data retention, and disclosure, they also risk becoming silent tools of unchecked

observation.

Speaking for myself, I'm adamantly opposed to the use of drones for

surveillance or law enforcement.

We're asking for a simple safeguard one rooted in constitutional duty and evidence-based policing:

Require a detailed, publicly accessible operating procedure for every stage of drone deployment activation, monitoring, data storage, and destruction. Each flight should generate a mandatory public log that records the meta data - date, time, duration, purpose, legal basis, and outcome. These logs must be retained and open to the public through FOIA, so residents can verify that drones aren't being used in ways that cross constitutional lines or target particular communities.


After the Supreme Court's recent ruling narrowing warrantless surveillance, local governments cannot wait for litigation to tell us what fairness should look like. DuPage County can set the standard for ethical technology use by requiring transparency before expansion.

Transparency is what sustains legitimacy because people understand how surveillance is used, they are more likely to cooperate, not less. When there is no transparency it breeds anxiety, withdrawal, and distrust.

So my question to this Board is this:

Will you commit today to directing the Sheriff's Office to create and publicly post a detailed operational policy and drone-flight log accessible to all residents under FOIA, with clear retention timelines and an annual public report?

We don't need more secrecy to feel safe, we need shared accountability. This is how DuPage protects both its people and its principles. Thank you.






