

Re: Request for Member Initiative Program Funding for Hinsdale Lake

Terrace Rideshare Access Program

In late 2024, DuPage County DOT (DuDOT), Pace Suburban Bus and Uber developed an agreement to provide much-needed transportation service in support of the Hinsdale Lake Terrace neighborhood in southeast unincorporated DuPage County. This service was promoted and supported by District 3 County Board members after much discussion with the residents and advocates of the neighborhood. The neighborhood has experienced many obstacles to success including economic and geographic isolation, joblessness, and reliable access to medical, social and food resources.

The Hinsdale Lake Terrace Rideshare Access Program Pilot (RAP) was designed to provide subsidized rides within a substantial service area that includes portions of Burr Ridge, Willowbrook, Darien, Downers Grove, Woodridge, Westmont and Hinsdale. Participants may use the service free of charge up to four times per day within the service area. Service began in January 2025, and enrollment has continued to increase weekly. In the first six months the RAP has delivered over 12,000 rides valued at more than \$100,000.

DuDOT originally budgeted \$100,000 for the pilot. To date, invoices have exceeded that budget and are projected to amount to almost \$500,000. The service has been extremely valuable to families and individuals in many facets of their lives and we believe it is in the best interest of the community to continue the Pilot. DuDOT appreciates the support of District 3 members and the entire Board in providing this service and is requesting additional financial support through the member initiative program.
