5. CHAIR'S REMARKS - CHAIR DESART

Chair DeSart gave very high praise and thanks to Sheryl Markay for her extensive work reading, distilling, tracking and prioritizing the over 6,500 bills that were filed to create the DuPage County Summary Bill List.

6. DISCUSSION**6.A. Overview of the Spring Legislative Session – Joe McCoy, Executive Director, Illinois State Association of Counties**

Joe McCoy provided an overview of the spring legislative session. He remarked that ISACo is tracking 900 bills that can be tracked on their website. Seventeen (17) of the bills they are supporting are also on the county's bill list. Mr. McCoy also encouraged DuPage to become more involved in NACo, mentioning that Mary Keating was a board member of NACo. Chair DeSart informed the committee that Chair Deborah Conroy recently named Member Sheila Rutledge as the county's NACo Representative. Mr. McCoy answered the committee's questions regarding shell bills and other bills that ISACo is tracking. Member Grant Eckhoff noted that he is concerned how quickly the shell bills can change.

Other Issues:

Restore LGDF Funding

Monies allocated under the Local Government Distributive Fund (LGDF), established in 1969 when the State of Illinois enacted an income tax, does not represent a “grant” from the State but rather a small share of income taxes paid by county residents that are returned on a per capita basis to support critical local services.

Under the original agreement with the State, units of local government were to receive 10% of total state income tax revenues which continued until 2011, when the State instituted a temporary income tax increase but failed to share the corresponding (increased) portion with local governments. In 2017, the General Assembly further reduced LGDF payments to local governments by 10% of state income tax revenues received, and in 2018, by another 5% of revenues received (to help balance the state budget).

As part of the Fiscal Year 2023 budget package, the General Assembly approved a modest one-year increase in local government’s total share of income tax proceeds, raising the amount distributed from the previous 6.06% of individual income tax collections to 6.16%, (for state fiscal year 2023 only), which translated into an annual increase of \$133,632 for DuPage County.

DuPage County, together with our municipal partners and the Illinois State Association of Counties (ISACo), urge the Illinois General Assembly to restore the distribution of LGDF dollars to the agreed upon 10% share of income tax proceeds to local governments.

Expand Tourism/Economic Development Opportunities

Tourism is a major driver of economic activity, contributing billions of dollars to the State’s economy that welcomed over 110 million visitors last year. The Illinois Office of Tourism (under the Illinois Department of Commerce & Economic Opportunity, DCEO) works with the (38) certified Convention and Visitors Bureaus statewide, including the DuPage Convention and Visitors Bureau (DCVB), to promote Illinois as a travel destination for meetings, conventions, domestic and international visitors as well as leisure travelers. In 2021, the tourism and hospitality industry employed nearly 400,000 people statewide.

DuPage County has 16,000 hotel rooms and last year, sent \$22 million in state hotel/motel tax receipts to Springfield yet the DuPage Convention and Visitors Bureau (as a capped bureau), received only \$1.5 million in return from the State Local Tourism Convention Bureau grant (that also required a \$750,000 local match). These dollars are critical to the success of local bureaus to attract meetings, conventions, tour groups and sporting events.

DuPage County requests that the Illinois Office of Tourism work with local bureaus to develop a strategy to provide additional discretionary grant funding for bureaus (based on performance), that generate significant economic impact for the State.



2023 STATE LEGISLATIVE PRIORITIES

DuPage County is the second-largest county in Illinois with nearly 1 million residents. DuPage is a major employment center for northeastern Illinois, home to 630,000 jobs, 90,000 businesses, two national laboratories, and 18 institutions of higher education. The DuPage County Legislative Committee identified these 10 legislative priorities for 2023, and the full County Board unanimously adopted the priorities on Jan. 24, 2023.

Allocate a Fair Share of Income Tax Revenues

Provide counties and municipalities with its fair share of income tax proceeds through the Local Government Distributive Fund (LGDF), that supports the delivery of critical local government services to our residents.

Promote Tourism and Economic Development Opportunities

Support certified convention and visitors' bureaus to help them compete with neighboring states, to attract major events to maximize economic opportunities.

Expand Mental Health Infrastructure

Support the rebuilding of Illinois' Mental Health infrastructure and workforce, expand access to substance use disorder and mental health care, prevent unnecessary hospitalizations, and properly fund innovative solutions and reimbursements to local providers.

Address Homelessness and Expand Affordable Housing Opportunities

Continue and expand resources directed toward ensuring housing stability.

Extend the Sunset of the Emergency Telephone System Act

Ensure the continued delivery of 911 emergency dispatch services and funding sources.

Reimagine our Public Transit System

Recognize the long-term impact of the COVID-19 pandemic on suburban ridership and the needs of the people of DuPage County. DuPage encourages the modernization of our public transit delivery system, including funding of sustainability and service flexibility that meets the needs of our evolving demographics, market forces, employer attraction, and retention, and ensures accountability of the transit service providers.

Enact an Illinois Child Tax Credit

Join 12 other states that offer child tax credits to help lift families with children out of poverty.

Keep our Communities Safe

Protect our residents from senseless gun violence through the enactment of stiffer penalties for the unlawful use of a weapon and for the possession and unlawful sale of ghost guns.

Support our Animal Population

Advocate for our animal population by providing that those who mistreat animals are held accountable for their actions, oppose any attempts to repeal the current ban on puppy mills, and enact other measures to protect animals from inhumane treatment.

Protect Our Environment

Support legislation reducing the impact our residents and businesses have on the environment by reducing waste and diverting materials from landfills.

Synopsis As Introduced

Amends the Humane Care for Animals Act. Provides that a person shall not perform surgical claw removal, declawing, or a tendonectomy on any cat or otherwise alter a cat's toes, claws, or paws to prevent or impair the normal function of the cat's toes, claws, or paws, except for a therapeutic purpose. Provides that the Department of Agriculture shall subject a person who violates the provisions to a civil penalty of \$500 for a first violation, \$1,000 for a second violation, and \$2,500 for a third or subsequent violation.

House Committee Amendment No. 1

Deletes reference to:

510 ILCS 5/3.10 new

Adds reference to:

510 ILCS 70/3.10 new

Replaces everything after the enacting clause. Amends the Humane Care for Animals Act. Reinserts the provisions of the introduced bill. Deletes that these provisions do not apply to a person who performs a procedure solely for a therapeutic purpose. Provides that surgical claw removal, declawing, or a tendonectomy on any cat or otherwise altering a cat's toes, claws, or paws to prevent or impair the normal function of the cat's toes, claws, or paws may only be performed by a veterinarian licensed under the Veterinary Medicine and Surgery Practice Act of 2004 for therapeutic purposes for the cat. Effective 90 days after becoming law.

Amends the Environmental Protection Act. Defines terms. Provides that, beginning January 1, 2025, a retail establishment may not sell or distribute in this State a disposable food service container that is composed in whole or in part of polystyrene foam. Exempts specified entities from the prohibition until one year after the amendatory Act's effective date. Effective immediately.

305 ILCS 5/5-47 new

Synopsis As Introduced

Amends the Substance Use Disorder Act. Requires the Department of Human Services to establish a Behavioral Health Receiving Center Grant Pilot Program to award a grant to one or more counties to develop and implement a behavioral health receiving center. Requires the Department to issue a request for proposals no later than July 1, 2023 and to award all grants before December 31, 2023. Prohibits the use of the grant to purchase land for the behavioral health receiving center. Provides that the purpose of the behavioral health receiving center project is to increase access to mental health crisis services for individuals who are experiencing a mental health crisis; and to reduce the number of individuals who are incarcerated or in a hospital emergency room while experiencing a mental health crisis. Requires a grant application to contain certain information including the population to which the behavioral health receiving center will serve, the type of mental health services that will be provided, and the cost of the proposed project. Requires the Department to report to certain House and Senate committees before June 30, 2024 regarding each county awarded a grant and the details of each project. Requires the Department to report to the committees before June 30, 2026 regarding certain data and recommendations for the future use of mental health crisis services in behavioral health receiving centers. Amends the Medical Assistance Article of the Illinois Public Aid Code. Requires the Department of Healthcare and Family Services to apply, no later than July 1, 2023, for a federal waiver or Title XIX State Plan amendment to provide reimbursement through a bundled daily rate for crisis management services that are delivered to an individual during the individual's stay at a behavioral health receiving center. Effective immediately.

Synopsis As Introduced

Creates the Carpet Stewardship Act. Provides that within 60 days after the effective date of the Act, the Director of the Environmental Protection Agency shall appoint specified members to a clearinghouse to administer and implement a carpet stewardship program. Specifies the duties of the clearinghouse. Requires the clearinghouse to be incorporated as a nonprofit. Provides that for all carpet sold in this State, the clearinghouse shall implement, and producers shall finance, a statewide carpet stewardship program that manages the product by reducing the product's waste generation, promotes its carpet recovery and reutilization, and provides for negotiation and execution of agreements to collect, transport, process, and market the old carpet for end-of-life carpet recovery or carpet reutilization. Requires the clearinghouse to submit, by July 1, 2024 and by July 1 every 3 years thereafter, a 3-year plan to the Agency for approval. Specifies the requirements for the plan. Establishes requirements for review of the plan and requirements for producers, retailers, and distributors of carpet. Requires the clearinghouse to submit annual reports to the Agency and pay specified administrative fees. Includes enforcement provisions for the Act. Establishes requirements for State procurement of carpet in the future. Contains a severability provision. Contains other provisions. Effective immediately.

Provides that an animal shelter shall not accept a dog or cat from an animal shelter licensed under the Act or an out-of-state animal control facility, rescue group, or animal shelter that is duly licensed in their state or is a not-for-profit organization unless it obtains documentation attesting that the dog or cat was not obtained through compensation or payment made to a cat breeder, dog breeder, dog dealer, or dog broker. Provides that an animal shelter shall not obtain a dog or cat by any means other than owner surrender, transfer from an animal control facility, an order by law enforcement, or an animal shelter in compliance with provisions concerning reporting of animals. Provides that a pet shop operator or dog dealer (rather than just a pet shop operator) may offer for sale a dog or cat only if the dog or cat is obtained from an animal control facility, animal shelter, or professional breeder (rather than just an animal control facility or an animal shelter) located in-state or out-of-state, that is in compliance with provisions concerning animal control facilities and animal shelters supplying to pet shop operators and requirements of professional dog breeders. Removes provisions concerning the requirement that a pet shop operator shall keep a record of each dog or cat offered for sale. Provides for requirements of professional dog breeders.
