Overview of the National Association of Counties (NACo) and member benefits – Brian Namey, Chief Public Affairs Officer, NACo

Mary Keating, Director of Community Services, asked Brian Namey to speak about NACo's Large Urban Caucus and also encouraged Board Members to take part.
